# **EJTF ACTIVITIES**

EJTF members participated (in freezing cold!) in the "Empower NJ: No Fossil Fuels" campaign kickoff, along with over 100 grassroots leaders representing 57 organizations and dozens of front-line communities. They stood united at the state capital on December 5, 2018, to call on Governor Murphy to enact an immediate moratorium on all fossil fuel development.

• The **"Empower NJ: No Fossil Fuels"** coalition campaign was launched on the same day world leaders gathered at the 24th annual UN climate conference to issue a stark warning that nations have a decade to cut their emissions in half by 2030 to prevent the worst consequences of climate change. Speakers stated that this warning will undoubtedly fall on deaf ears with the Trump administration, which is why Governor Murphy is being urged to live up to his climate commitments and lead a coordinated state-level effort to rapidly reduce green house gas emissions, starting with an immediate moratorium on all fossil fuel development.

Participated in "ambush" of legislators' meeting on proposed redistricting (aka "gerrymandering") amendment bill **(SCR152 and ACR205)**!



EJTF representatives, along with others from UUFaithAction NJ, Working Families Party, League of Women Voters, and NJ7 Citizens for Change, staked out meetings held by Democratic legislators on December 12, 2018, in advance of the legislative hearings to be held the next day (see page 3). The "ambush" was organized primarily by Analilia Mejia of the Working Families Party.

- NJ legislative leaders--primarily Democrats--supported an amendment to the NJ constitution (SCR152 and ACR205) that was a purely political proposal to increase the ability of politicians to choose their voters. The usual term for it is "gerrymandering." It would also have embedded the two-party system into the state's constitution, a blatant attempt to weaken third parties like the Green and Libertarian parties. Every group that testified on the proposed amendment opposed it. Voting on the bill was scheduled for December 17, 2018, but **thanks to all the opposition, the Senate President Sweeney and Assembly Speaker Coughlin pulled the resolutions proposing the amendment on December 15!!** Earlier that day, Senate Majority Leader Loretta Weinberg said in an interview on NPR that "There's something in this bill to affront almost everybody."
- This amendment would have flown directly in the face of UU's 5th Principle: "*The right of conscience and the use of the democratic process within our congregations and in society at large.*" The amendment not only gave the sitting Senate president, House speaker, and minority leaders the power to appoint eight members to the redistricting commission, it also required that four of those appointees must be sitting legislators. This would clearly have empowered elected officials to have an oversized influence on who votes in their own or their own party's races.
- We will be closely watching for any replacement bills to this proposed redistricting amendment.

We also testified, along with 140 people from at least 100 different groups, at legislative hearings on the proposed redistricting amendment bill, on December 13, 2018. The League of Women Voters spearheaded the effort.

• Attended **Jersey Water Works Conference** on December 7, 2018. Covered were: 1) the role of the NJ Department of Environmental Protection (DEP), whose current priorities are as follows: climate change; protecting water; and, protecting the health of New Jersey communities, with particular focus on EJ communities; 2) the "water message paradox" – "The water is safe to drink... Everything is falling apart we need 1 million dollars;" and, 3) the case for water affordability, focusing on the fact that drinking water is an EJ issue, recognizing the importance of the infrastructure (Trump has signed a water infrastructure bill), and that we are seeing a startling return to piping sewage directly to the environment. Key questions are: "How much **should** a poor household be expected to pay for essential services? What sacrifices should be expected?

#### 3) Promote low-income Community Solar in NJ

• EJTF participated in Stakeholder meetings to create NJ's new program, reviewed and commented on the proposed rule that was issued, testified at the hearing for the draft rule, and commented on the draft rule.

• In the future, EJTF plans to follow progress on the Community Solar Pilot to emphasize both jobs and lowering bills. Utility scale solar is cheapest for rate payers; developers find Low- and Moderate-Income (LMI) subscribers most expensive to sign up; and finance groups consider projects including LMI subscribers most risky. So providing community solar for LMI households is not necessarily a big benefit for them. Jobs provided should be local if possible, or at least be in New Jersey.

# EJTF KEY ISSUES FOR 2019:

#### 1) Reducing Green House Gas (GHG) emissions from transportation

• Participated in joint legislative hearing on S2252, a comprehensive bill that establishes goals, initiatives, and programs to encourage and support use of plug-in electric vehicles. <u>https://legiscan.com/NJ/bill/S2252/2018</u>

#### 2) Fighting against fossil fuel infrastructure –

• Three members of EJTF attended a strategy meeting for getting Governor Murphy to put a moratorium on building more fossil fuel infrastructure in NJ.

• UU FaithAction NJ also signed off on a joint letter to Governor Murphy, stating "it is high time to stop the dirty and dangerous expansion of oil and gas pipelines and other unnecessary fossil fuel developments in New Jersey. New Jersey needs a moratorium on new fossil fuel development."

# "GREEN AMENDMENT" - Sponsored in the Assembly by UU Nancy Pinkin

The "Green Amendment" bill (Senate Concurrent Resolution 134), for a proposed amendment to the NJ Constitution to grant every person the right to a clean and healthy environment, passed the NJ Senate Environment and Energy Committee by a bipartisan supermajority. It was sent to the Senate Budget and Appropriations Committee 10/15/2018. EJTF supported a letter-writing campaign on its behalf over a year ago.

## NEW JERSEY ENVIRONMENT-RELATED BILLS PASSED 1/1/2018 – 12/14/2018 for bill text: go to Legiscan.com/NJ and search by bill number.

NJ <u>A4120</u> (Passed 8/24/2018) - Authorizes special assessments and bond issuance to **replace lead-contaminated water service lines.** 

NJ S1217 (Passed 5/30/2018) - Requires BPU consideration and approval of amended application for qualified **wind energy project offshore** in certain NJ territorial waters

NJ A3723 (Passed 5/23/2018) - Establishes and modifies **clean energy and energy efficiency programs**; modifies State's **solar renewable energy portfolio standards**, adds **Community Solar**.

NJ S2313 (Passed 5/23/2018) - Establishes zero emission certificate program for nuclear power plants.

NJ A839 (Passed 4/20/2018) - **Prohibits offshore oil and gas exploration, development, and production** in State waters, and issuance of DEP permits and approvals for activities associated with offshore oil and gas activities

 $\rm NJ$  SR29 (Passed 2/26/2018) - Opposes expansion of oil and natural gas drilling on Outer Continental Shelf.

NJ S598 (Passed 2/21/2018) - Requires NJ to join U.S. Climate Alliance to uphold Paris Climate Accord.
