March in Red Bank

People's Climate Movement Marches - "Rise for Climate, Jobs, and Justice"

UU congregations joined in the September 8, 2018 marches, including those in Morristown (co-sponsored by UU Faith Action) and Red Bank. The UU Congregation of Monmouth County joined about 100 people to march in Red Bank. They marched from Riverside Park along the Navesink River, through the downtown, ending in Marine Park, led by a group of 5 drummers! At Marine Park many different people - mostly environmentalists and local politicians - gave short speeches, and there were tables with environmental information. The threatening rain very obligingly didn't materialize, and thankfully neither did the heat!

In Morristown, the UU Ocean County Congregation and Beacon UU Congregation in Summit marched, along with about 400 people. The high points of that event were Amy Goldsmith of Clean Water Action explaining how the trucks in the port of Newark are befouling the air, and Nicky Sheats, President of the New Jersey Environmental Justice Alliance (NJEJA), explaining the opposition of NJEJA to the Regional Greenhouse Gas Initiative (RGGI).

NEW JERSEY ENVIRONMENT-RELATED BILLS PASSED 1/1/2018 - 9/25/2018

NJ A4120 (Passed 8/24/2018) - Authorizes special assessments and bond issuance to **replace lead-contaminated water service lines.**

NJ S1217 (Passed 5/30/2018) - Requires BPU consideration and approval of amended application for qualified **wind energy project offshore** in certain NJ territorial waters

NJ A3723 (Passed 5/23/2018) - Establishes and modifies **clean energy and energy efficiency programs**; modifies State's **solar renewable energy portfolio standards**, adds **Community Solar**.

NJ S2313 (Passed 5/23/2018) - Establishes zero emission certificate program for nuclear power plants.

NJ A839 (Passed 4/20/2018) - **Prohibits offshore oil and gas exploration, development, and production** in State waters, and issuance of DEP permits and approvals for activities associated with offshore oil and gas activities

NJ SR29 (Passed 2/26/2018) - Opposes expansion of oil and natural gas drilling on Outer Continental Shelf.

NJ S598 (Passed 2/21/2018) - Requires NJ to join U.S. Climate Alliance to uphold Paris Climate Accord.

EJTF Testimony at NJ Energy Master Plan Stakeholder Meetings

9/7 - Clean & Renewable Energy

[Rev. Ronald Tuff of Greenfaith testified with EJTF, and called for hearings to be held nearer Newark to make these meetings accessible to more people.]

I am Nancy Griffeth from Unitarian Universalist Faith Action. Thank you for letting me speak today.

Thirty years ago, we could have fixed this easily. Ten years ago, we had a good start on it. But very little was actually done. Now, we face increasing damage and danger from climate change. We must move quickly now, perhaps even more quickly than we believe we can. Here are the essential things that UU Faith Action urges: Don't allow any more fossil fuel infrastructure to be built. A discussion point raised the question of "stranded assets." Investments in fossil fuel infrastructure will all be stranded assets, so let's not invest there any more. It's time for all our investment to be going to clean, renewable energy.

But the cleanest energy is no energy, so please emphasize energy efficiency. Let's reduce our use of energy.

The transportation sector is the biggest user of energy, so we must focus there. Encourage use of electric vehicles, while converting the electrical grid to renewable energy. Convert state fleets and NJ Transit to electric vehicles. Require trucks to reduce emissions and convert to electricity as quickly as possible.

Poorer communities are overburdened by emissions from vehicles and power plants and by the consequences, like flooding, of climate change. We need to take action to lift this burden. As we convert to new industries, supporting new forms of energy, we must include them in the benefits with job training and jobs and with community-based sources of energy such as Community Solar.

The cost in dollars may be high, but the cost in human suffering will be much higher if we do too little.

9/14 - Reducing Energy Consumption

I'm Nancy Griffeth from Unitarian Universalist Faith Action. We're partners in Jersey Renews..

Thank you for giving emphasis to reducing energy consumption and for the good work that the Office of Clean Energy has been doing. We have been impressed with the BPU's efforts to help New Jerseyans reduce their energy use.

However, conversations with people in the building industry told us that there is a problem with the Societal Benefits Charge. A contractor said that he works in both Short Hills and Elizabeth, and that almost all the rebates go to Short Hills. But since everyone pays the societal benefits charge, this amounts to a transfer of wealth from poorer communities to wealthier ones.

We appreciate the motivation of the Societal Benefits Charge, and we believe this side effect is entirely unintentional. We also believe that it's important to incentivize energy reduction, but we want to incentivize in a way that rewards all citizens for their efforts, not just the wealthy ones.

So, we challenge the BPU, and all of the environmental justice advocates here in the room, to come up with approaches that will encourage and reward energy efficiency in LMI households as well as in rich ones.

There are a number of other issues that we addressed in our comments, including improving and electrifying NJ Transit and state fleets, modifying the building code to encourage green buildings, and other things. I'm sure that you'll hear a lot about these in subsequent comments, but we wanted to emphasize the importance of rewarding energy efficiency in disadvantaged communities as much as in wealthy ones.
