## EJTF ACTIVITIES


**"Bird-dogging" Governor Murphy:** One of EJTF's 2019 goals (see page 4), is "Getting Off Fossil Fuels. Related to this goal, we are part of a coalition ("EmpowerNJ") advocating for Governor Murphy to enact a moratorium on new fossil fuel infrastructure. On January 15, members of EJTF joined others from EmpowerNJ to "bird-dog" Governor Murphy at his "State of the State" speech at the State House Annex.



#### "Bird-dogging" Governor Murphy (continued):

We greeted Governor Murphy with a strong, unified message: "You can't fight climate change and achieve 100% renewable energy while continuing to approve new oil and gas pipelines and power plants. New Jersey needs a moratorium on fossil fuel projects now!" There were about 10 of us in the hallway before Murphy's State of the State on January 15, 2019, including Matt Smith of Food and Water Watch (center, in the panorama picture on the page 2); also Junior Romero, Gene Schaedel, and Cassandra Worthington of Food and Water Watch; Rhyan Grech of the Pinelands Preservation Alliance; Rena Amada of UUCMC; Carol Gay of the NJ Industrial Union Council; and, Nancy Griffeth, Chair of the UUFANJ EJTF.

Environmentalists Jeff Tittel (Sierra Club), Dave Pringle (who was a candidate to replace Leonard Lance in NJ Congressional District 7 and is a public interest advocate), and Amy Goldsmith of UUCMC and Clean Water Action participated as invited guests and attended the speech.

### EJTF KEY ISSUES FOR 2019:

#### 1) Reducing Green House Gas (GHG) emissions from transportation

#### - Electric Vehicles (EV's)

We are working on a draft position on EV's and one of the bills in the NJ Assembly concerning EV's.

#### 2) Fighting against fossil fuel infrastructure

We are working on actions related to achieving a moratorium on new fossil fuel infrastructure in NJ (see "Bird-dogging Governor Murphy" on pages 2 and 3). We have joined a coalition, named "EmpowerNJ" (Twitter hashtag, #empowernj). Members of the "Stop Fossil Fuel Campaign" coordinating committee are preparing a report that will articulate the evidence-based case for a moratorium on fossil fuel projects in New Jersey. They hope to finalize and publish the report in the coming weeks,

We are also drafting letters that can be sent to local newspapers, and plan to begin having informational forums for our congregations and in our municipalities; the communications.

#### **ENVIRONMENTAL JUSTICE**

#### NJ Environmental Justice Executive Order No. 23 Draft Guidance Released with Public Comment Period and Listening Sessions

The Department of Environmental Protection has issued a draft guidance document that aims to improve public health, the environment and quality of life in all communities statewide. The document is the centerpiece of Governor Murphy's Executive Order No. 23, which calls upon all state government agencies to make environmental justice a key consideration in decision making that affects residents' environment, communities, homes and health. The goal is to ensure that every resident —regardless of race, ethnicity, color, national origin or income— receives equal protection under state laws and can live and work in a healthy, clean environment.

The executive order, signed by Governor Murphy on 4/20/2018, directs the DEP to take the lead in developing environmental justice guidance for state agencies. The draft document culminates an interagency panel's months-long effort to gather views and critical information on environmental justice from members of impacted communities, conservation and planning organizations, business and industry, and municipal and legislative representatives.



#### **"GREEN AMENDMENT"**

Sponsored in the Assembly by UU Nancy Pinkin

The "Green Amendment" bill (Senate Concurrent Resolution 134), for a proposed amendment to the NJ Constitution to grant every person the right to a clean and healthy environment, passed the NJ Senate Environment and Energy Committee by a bipartisan supermajority. It was sent to the Senate Budget and Appropriations Committee 10/15/2018.

• Solar Energy for the Less Well-off in NJ –A Pilot Program is Approved –

This is the Community Solar Pilot Program, one of the EJTF goals last year!! We pushed the state to consider Environmental Justice communities, have more hearings accessible to Environmental Justice communities, and include reporting of the actual impact on Environmental Justice communities.

The state on 1/18/2019 approved a pilot program aimed at making solar energy available to low- and moderate-income households, a policy that could lower their energy bills.
