


REMINDER! UU FaithAction NJ PLENARY IS APRIL 13, 2019!

UPCOMING EVENTS

FORUMS – Empower NJ: For a Moratorium on New Fossil Fuel Infrastructure

Empower NJ is a coalition of more than 50 environmental groups, demanding that Governor Murphy declare a moratorium on new fossil fuel infrastructure until there is a plan in place to comply with the Global Warming Response Act of 2007 and to reach Governor Murphy's goal of 100% renewable energy by 2050. Neither of these will be possible if any of the 12 fossil fuel projects (8 pipeline/compressor projects and 4 power plants) is completed. See their Facebook page here.

EJTF ACTIVITIES

UPDATE ON EJTF KEY ISSUES FOR 2019:

1) Fighting against fossil fuel infrastructure

We are working on actions related to achieving a moratorium on new fossil fuel infrastructure in NJ. We have joined Empower NJ - Twitter hashtag, #empowernj - (see "Forums" on page 2), a coalition of environmental groups, to demand that Governor Murphy declare a moratorium on building fossil fuel infrastructure, just as <u>Governor Brendan Byrne did to prevent development in the Pinelands</u> and <u>Governor Thomas Kean did to protect freshwater wetlands in New Jersey</u>. We are asking our members to contact the governor and to write letters to print and on-line news sources, to attend demonstrations against new pipelines and power plants, and to organize educational events in their congregations and in our municipalities.

UPDATE ON EJTF KEY ISSUES FOR 2019 (continued):

- 2) Reducing Green House Gas (GHG) emissions from transportation
 - Electric Vehicles (EV's)

Legislation: For electrification of New Jersey's transportation sector, we are supporting New Jersey Senate Bill 2252, which "establishes goals, initiatives, and programs to encourage and support use of plug-in electric vehicles," and are asking for additional incentives for replacing diesel buses, especially school buses, in New Jersey with electric buses. We are working on a draft position paper on EV's.

Volkswagen settlement Funds: The state is allocating \$11.2 million from a Volkswagen settlement to install electric-vehicle charging stations at hundreds of locations around New Jersey and to buy new electric buses for NJ Transit in Camden. One focus of the funds is to be on environmental justice to communities which are disproportionately impacted by pollution and resulting health impacts. The new electric buses in the City of Camden will be a step toward electrifying public transportation in New Jersey, and directly addresses one of EJTF's priorities. ACTIONS RELATED TO EJTF AREAS OF INTEREST

"GREEN AMENDMENT" Sponsored in the Assembly by UU Nancy Pinkin



The "Green Amendment" bill (Senate Concurrent Resolution 134), for a proposed amendment to the NJ Constitution to grant every person the right to a clean and healthy environment, passed the NJ Senate Environment and Energy Committee by a bipartisan supermajority. It was sent to the Senate Budget and Appropriations Committee 10/15/2018.

LEGISLATION THAT WOULD PROVIDE A BARRIER FOR NEW JERSEY AGAINST THE TRUMP TEAM'S ROLLBACK OF ENVIRONMENTAL RULES

• UU Nancy Pinkin, (Chair of the NJ Assembly Environment and Solid Waste Committee) proposed legislation on 2/14/2019 that would keep federal regulations from the pre-Trump era in force in New Jersey.



- The bill (A5033) would authorize a NJDEP rulemaking to prevent backsliding or weakening of certain State environmental regulations due to changes in federal law or regulation.
- Specifically, it addresses endangered species, air pollution control, water pollution control and safe drinking water, and would maintain them at a minimum level in effect on January 19, 2017 (the day before the last Inauguration Day). The related federal laws establish standards that serve as the baseline level for environment, natural resources, and public health protection, while authorizing states to adopt more protective measures. However, beginning in 2017, the President and United States Congress have engaged in efforts to weaken these federal laws and the protections they provide.
- This bill is intended to ensure continued protections for the environment, natural resources, and public health in New Jersey even if these federal laws are weakened, and would retain the protections afforded under the federal laws and implementing regulations in effect on January 19, 2017, regardless of actions taken at the federal level to weaken those protections. This bill is similar to legislation pending in California.

ENVIRONMENTAL JUSTICE -NJ Environmental Justice Draft Guidance Document

The Department of Environmental Protection has issued a draft guidance document pursuant to Executive Order No. 23, which calls upon all state government agencies to make environmental justice a key consideration in decision making that affects residents' environment, communities, homes and health. The executive order, signed by Governor Murphy on 4/20/2018, directs the DEP to take the lead in developing environmental justice guidance for state agencies. POLLUTION



• Legislation (S1073) that will allow counties and municipalities in New Jersey to establish stormwater utilities and management policies was signed into law March 18, 2019 by Governor Phil Murphy: http://enviropoliticsblog.blogspot.com/2019/03/by-frank-brill-enviropolitics-editor.html#.XJENCu_sapo

S1073 does not directly impose any fees on property owners. Instead, it allows municipalities and counties to create their own local stormwater utilities that could then charge property owners a fee based on "a fair and equitable approximation" of how much runoff is generated from their property. The utility could then use the funds generated by the fees only on its system, such as reinforcing or replacing pipes or creating green infrastructure like rain gardens and tree planting to absorb water that would otherwise carry trash, bacteria and heavy metals.

"This is a tool that would only be used by towns that recognize they have a problem," said Chris Sturm, a water policy expert with New Jersey Future, a nonprofit that advocates a balance between economic development and environmental protection. "It's an important tool. It's one that can make a significant difference in the right towns."

The NJDEP will likely spend considerable time developing rules for the law. Then towns and counties need to determine whether they need such a utility. Local officials will then decide if they have the political will to issue fees to large property owners - some of whom already pay among the highest property taxes in the community.
