#### NJBPU Net Metering Policies for Class I Renewable Energy Systems Comments Requested

The NJ Board of Public Utilities (BPU) is seeking stakeholder input on the successes and obstacles of comparable approaches to guide the policy planning process for future changes in net metering. "Net metering permits owners and operators of class I renewable energy generation facilities to receive credits for any electricity that is supplied back to the electric grid. In New Jersey, net metering is predominantly utilized for solar installations at residential, commercial, and public entity locations. Net metering must be offered at non-discriminatory rates to accommodate systems of any sized capacity." A public meeting was held by the BPU in November, for which the video and the presentation slides are available. No due date for comments has been given. #### NJBPU Notice of Substantial Changes to Community Solar Rules Comments Due 12/6/2024

The NJ Community Solar Pilot Program was initially created in 2018, and the initial rules for the Pilot Program are still in effect, despite the program being judged as a success by the NJ Board of Public Utilities (BPU) with the intention of making it a permanent program. Amendments to the Pilot Program rules that would create the permanent program were proposed in September 2023, but were never adopted in light of the substantial comments received. In response to the comments, the BPU has now issued a "Notice of Substantial Changes" to those proposed rules.

#### NJBPU Energy Storage Incentive Program 2024 Straw Proposal Comments Due 12/18/2024

The NJ Board of Public Utilities (BPU) has issued a Straw Proposal for the NJ Storage Incentive Program (NJ SIP) that is intended to "build a critical foundation for a long-term energy storage effort in the State.... In this 2024 Straw Proposal, ('Straw')... the ...BPU... proposes to create two energy storage segments for Front-of-Meter and Behind-the-Meter energy storage incentives, patterned after the [BPU's] Successor Solar Incentive (SuSI) Program. However, while the SuSI Program incentivizes stand-alone solar and Grid Supply solar-plus-storage projects, this Straw will focus on incentivizing stand-alone Grid Supply energy storage projects as well as solar-plusstorage projects that are ineligible to receive storage incentives from the SuSI Program." Comments are due by 5:00 p.m. on

12/18/2024. ## Cape May County EJ DEP Community Engagement Session - Video and Notes from Meeting

The NJ Department of Environmental Protection (DEP) invited Cape May County residents to attend a community engagement session regarding Environmental Justice, with DEP Commissioner Shawn LaTourette and the U.S. Environmental Protection Agency (EPA) Region 2 Regional Administrator Lisa Garcia. This community engagement session was one of a series being conducted by DEP in communities across NJ, intended to provide residents, community groups, and other members of the public with a chance to discuss environmental justice issues. However, at this session, a number of attendees raised questions about the DEP "Resilient Environments and Landscapes" (REAL) proposed rules under the "NJ Protecting Against Climate Threats" (NJ PACT) initiative. Public officials and residents challenged the proposal, and Commissioner LaTourette while promising to meet with local officials to discuss it - called out "misinformation" as contributing to some of the concerns. Some attendees pointed out what they said was a lack of local input during development of the proposed rules. Starting at minute 30:35 of the video, and over the course of the rest of the meeting,

Commissioner LaTourette gave a comprehensive and very articulate description of the REAL proposed rules and their intended impact. The video is available here:

#### "Should We Stay or Should We Leave? Multi-objective Tradeoffs In Identifying Robust Beach Nourishment and Managed Retreat Strategies" - Video of Webinar

This talk, part of the Dartmouth "New Energy Series," was presented by Prabhat Hegde, PhD Candidate, Dartmouth. "In some low-lying coastal areas around the world, decision-makers are beginning to consider 'managed retreat' of human populations to adapt to sea-level rise. Decision-makers lack tools and scientific understanding to evaluate whether the benefits of interim response strategies, like beach nourishment, outweigh the costs of waiting longer to trigger retreat. In this talk... Prabhat Hegde... contextualize[d] the coastal beach nourishment problem within the umbrella of decision analyses frameworks for climate change adaptation... [and]....demonstrate[d] how considerations of uncertainty and multiple objectives improve upon existing decision-making practices, drastically changing expected outcomes and the recommended timing of retreat." ### Truck Charging Stations Coming to NJ Turnpike

This 5-minute news video focuses on nine new electric truck charging stations that will be constructed along the NJ Turnpike, funded by a \$250 million Climate Pollution Reduction Grant from the U.S. Environmental Protection Agency (EPA). The grant will fund 24 charging stations in 4 states. The charging stations are particularly needed in NJ so that the trucking industry can comply with the Advanced Clean Truck (ACT) rules, which require increasing percentages of zero-emission trucks to be sold, beginning 1/1/2025. A bill (A4967/S3817) has been introduced that would delay implementation of the ACT requirements for two years (see the article below).

In NJ, "Siemens Corporation, Technology (Princeton, NJ) will receive \$7,998,766 to demonstrate an automated approach for battery disassembly to reduce cost while maintaining the flexibility to handle a variety of types of packs."

Utilizing a combination of a newly-operational oncampus solar array and Renewable Energy Certificates (RECs) from a combination of on-site and off-site (i.e., partnership in a large-scale solar facility to be constructed in western Kentucky) renewable energy projects, Lehigh University has addressed 100% of its energy consumption. The University has a goal of achieving net carbon neutrality by 2040.

#### Rutgers Receives Grant from USDA to Develop an Alternative to Hydroponics Method

From Rutgers Today: "Rutgers Health received a \$607,000 grant from the U.S. Department of Agriculture to develop 'electroponics,' an alternative to the hydroponics approach to farming that would allow plants to grow under limited water conditions or in zero gravity conditions ready for deployment in space stations. The idea

behind the research is to adapt farming to conditions resulting from climate change where water is a rare commodity and to precisely target the delivery of agrichemicals that can cause serious environmental pollution.... The proposed novel and game-changing technology uses electrospray as a method of precisely delivering water in the form of electrically charged micronsize particles and biopolymer-based nanofibers extracted from food waste that can be used as seed coatings to enhance germination and plant growth suitable for many types of edible plants such as lettuce."

#### Governor Murphy Signs Memorandum of Understanding with Climate Group, as New Jersey Joins Under 2 Coalition

According to its website, Climate Group is "an international nonprofit founded in 2003, and officially launched in 2004, with offices in London, New York, New Delhi, Amsterdam and Beijing. Over the last 20 years, we've grown our network to include over 500 multinational businesses in 175 markets worldwide. We also work closely with governments at all levels. The Under2 Coalition, for which we're the Secretariat, is made up of 167 state and regional governments and has been named one of the international cooperative initiatives with the highest potential for emissions reductions." NJ has signed a Memorandum of Understanding (MOU) to join 16 other U.S. states in this, "the largest global network of states and regions committed to achieving greenhouse gas (GHG) emissions mitigation." Members and MOU signatories collaborate in supporting international activities and declarations to respond to climate change. "In line with the Paris Agreement, the

guiding principle for reduction of GHG emissions by 2050 must be to limit global warming to no more than 1.5°C. For Parties to this MOU, this means acting as climate leaders and pursuing an emissions reductions trajectory consistent with achieving net zero emissions by 2050 as a Coalition, and individual net zero emissions as soon as possible, in line with the most recent science."

Designated roads shown on the map, called the Wharton State Forest Visiting Vehicle Use Map, enhance the visitor experience and public safety by supporting State Park Police patrols and the ability to conduct routine maintenance and improving access for emergency response personnel. Further, the map serves to ensure the protection of wildlife habitat and rare plant species found within the forest. #### LEAD REDUCTION IN HOUSEHOLDS

In addition to lead exposure being an issue in infants after birth, research has found that lead present in the mother's bloodstream before birth passes through the placenta, and in addition to impacting the baby, it can lead to health risks of the type found in maternal mortality and morbidity that is occurring in NJ. In some cases, the lead level in the bloodstream increases later in pregnancy, due to "remobilization" of lead from possible long-ago exposures that was locked in the mother's bones and is released as bones change to release calcium (and lead) during pregnancy and also breast-feeding. There are treatments that can address this issue, but there is no requirement to screen for lead during pregnancy. A bill (S3616/A4848) would require such screening if risk factors are found. #### Murphy Administration Announces Approval of Triennium 2 Energy Efficiency Programs

The NJ Board of Public Utilities (BPU) approved the Triennium 2 (T2) energy efficiency programs proposed by NJ's seven electric and gas utilities. From the BPU press release: "Triennium 2 is the second cycle of the State's multi-year utility-run energy efficiency programs. Established by the Clean Energy Act of 2018, natural gas utilities must achieve energy savings of 0.75% and electric utilities must achieve energy savings of 2% of the average annual usage in the prior three years within five years of implementation of their energy efficiency programs.... To promote energy

equity, the Income-Qualified Program will have more capacity compared to T1 [Triennium 1] to provide comprehensive home energy assessments and offer health and safety, weatherization, HVAC, and other energy efficiency upgrades at no cost to eligible customers. More broadly, programs across the utilities' portfolios will continue to include enhanced incentives and more favorable financing terms for income-eligible customers. One notable addition in T2 is the standardization of the Direct Install model, including a Public Sector Direct Install program pathway, which will help support partners in labor in growing a local workforce that represents the diverse fabric of our state." https://www.nj.gov/bpu/newsroom/2024/approved/20 241031.html

### **EPA Announces Historic \$400M Clean Ports Investment in New Jersey**

From the U.S. Environmental Protection Agency (EPA) press release: "Today [10/30/2024], the U.S. Environmental Protection Agency announced nearly \$400 million in Clean Ports Program funding for the Port Authority of New York and New Jersey and SeaStreak LLC. This transformative investment, part of President Biden's Investing in America agenda, will fund new zero-emission equipment and infrastructure, alongside comprehensive climate and air quality planning." The funds will primarily go to electrify port operations, as well as upgrading the SeaStreak ferry fleet to zero-emissions. A Community Advisory Committee to give local residents input on the plans will also receive funding. At the ports, funding will help replace cargo handling equipment, allow ships to plug in when they are in port, provide voucher incentives to truck drivers to upgrade trucks to zero-emission capability, and support workforce development and training. #### EPA Announces Rowan University to Receive \$350,000 Grant to Help Businesses Prevent Pollution as Part of Investing in America Agenda

Rowan University has been selected to receive nearly \$350,000 in grants to provide technical assistance to businesses to develop and adopt pollution prevention (P2) practices in local communities. Rowan University's project focuses on the reduction of specialty chemicals with high global warming potential. Many of these chemicals are used in the electric power industry and in microelectronics processing. Pollution prevention is achieved via reduction in greenhouse gas (GHG) emissions, energy utilization, material use, hazardous wastes, as well as cost savings, and the innovative integration of all the above when taken together creates greener facilities that could serve as role models for allied industries to follow. Rowan University is currently working with one of the largest domestic providers of Sulfur Hexafluoride (SF6) for equipment used by electric utilities. Rowan also plans to coordinate with the Electric Power Research Institute to leverage the research that has been done in the past."
