#### Heading Into the Future

The Environmental Justice Task Force (EJTF) of UUFANJ is heading into the future determined to step up our efforts to "educate, advocate, and mobilize" in the cause of environmental justice. Our current goals are described in the box below. We will continue to make our voice heard in the NJ legislature as we support key bills, such as the NJ Climate Superfund Act, and oppose others (see the box on p. 19). Also, we will encourage UUs to have an impact on the NJ Governor's race by interacting with gubernatorial candidates to highlight our issues (also see the articles on p. 17 <a href="here">here</a> and <a href="here">here</a> and <a href="here">here</a> about "Enviro Fix in '26," a nonpartisan environmental agenda for the next governor, launched by NJ environmental advocacy groups).



#### **EJTF's GOALS for 2024/2025**

- 1. Advocating for the adoption of the Green Amendment in New Jersey through work in our congregations and as a Task Force;
- 2. Working toward resolving the many challenges in New Jersey related to food-insecurity, including but not limited to promoting regenerative agriculture, increasing accessibility of healthy food, reducing food waste, and encouraging community and family gardens;
- 3. Supporting 100% renewable energy and energy conservation through measures such as the Clean Energy Equity Act, and those affecting transportation and Electric Vehicles (EVs).
- 4. Advocating for better health and reducing climate change for all by protecting and expanding New Jersey's public and urban forests.
- 5. Advocating for a better understanding of the interconnected web of life by influencing education for people of all ages, including public school curriculum of K-12 students.

#### New "Target Zero" Law A Win for Safe Streets in NJ!!

In 2024, traffic-related fatalities in New Jersey climbed to 692, the second-highest number since 2007. The largest increase was among pedestrians: There were 223 pedestrian deaths in 2024, the highest number since 1988.

After more than two years of advocacy, Governor Murphy signed the Target Zero Commission Bill into law on Monday, January 13, taking a critical step towards making New Jersey streets safer for all users. The bill was passed by both the Senate and the Assembly unanimously on December 19, 2024. New Jersey becomes the first state in the nation to establish a Commission dedicated to reaching zero traffic deaths and serious injuries by 2040.

This is a victory that we worked on through UU FaithAction NJ for the last two years as a partner-member of the NJ Bike & Walk Coalition.

A similar Target Zero safety campaign in the Netherlands in the 1970s moved that country from a car-dominated culture to one of the world leaders in walking, biking, and mass transit. It took many years of concerted effort after setting up the safety goals and administrative institution, but the results have saved lives, and improved health, air quality, and the economy for the entire country.

Jersey City, New Jersey has already implemented such a program and has achieved similar benefits. They have successfully driven annual deaths on roads and walkways to zero.

We can be proud of this milestone and prepare to actively participate at the state, county, and local community levels to carry this forward.

The following is from Gov. Murphy's press release: "Governor Phil Murphy today [1/13/2025] signed A1476/S361 into law, creating the Target Zero Commission with the goal of eliminating traffic deaths and serious injuries in New Jersey by 2040. The 13-member group will consist of state officials from the Department of Transportation (DOT), State Police, along with the Division of Highway Traffic Safety, the New Jersey Turnpike Authority, regional transportation officials, and others who will work together to make New Jersey's roads safer for drivers and pedestrians.... 'The Commission will collaborate to prioritize safety and mobility, forging a clear path to making sure everyone, whether walking, biking, driving, or using public transit, can travel safely in New Jersey,' said Governor Murphy.

The Target Zero Commission will focus on data-driven strategies that prioritize roadway design, speed management, and safety for all road users, including pedestrians, cyclists, and drivers. The Commission will advise the Governor, Legislature, and the DOT regarding policies, programs, research, and priorities that will aid in attaining the goal of eliminating traffic fatalities. Under the law, the Commission is directed to propose an action plan within one year of the bill's signing, with a chance for the public to provide feedback on the proposed plan. The Commission will also collect traffic safety data for the public, including data on dangerous intersections and crash demographics. Additionally, the Commission will provide data and resources to local municipalities to assist them in developing their own Target Zero plans."

NJBPU Technical Conference on NJ's Net Metering Policies for Class I Renewable Energy Systems 2/10/2025, 1:00 p.m. - 4:00 p.m. - Webinar

The NJ Board of Public Utilities (BPU) is holding a Technical Conference for stakeholders to present their perspectives on possible designs of a net energy metering ("NEM") successor policy in NJ. "Net metering permits owners and operators of class I renewable energy generation facilities to receive credits for any electricity that is supplied back to the electric grid. In New Jersey, net metering is predominantly utilized for solar installations at residential, commercial, and public entity locations. Net metering must be offered at non-discriminatory rates to accommodate systems of any sized capacity." A public meeting was held on this topic by the BPU in November, for which the video and the presentation slides are available (see below). The presentations from this Technical Conference will be taken into consideration when the BPU develops a shortlist of potential NEM successor policy options in the subsequent phase of this stakeholder process. Among other things, presenters at the meeting are encouraged to describe major enablers and barriers to efficiently and fairly evolving the NEM structure. ### Princeton Schools Will Add 2 Electric Buses To Fleet By Next Summer

Utilizing funds from a NJ Department of Environmental Protection (DEP) grant of up to \$620,000, plus revenue from the sale of an older bus and a \$40,000 federal clean vehicle credit, the Princeton Public Schools (PPS) are purchasing two electric buses and a fast-charging station which can send energy back to the grid during high-demand periods. ## Trump Rule Allowing Liquefied Natural Gas (LNG) to Be Transported by Rail Vacated by Court

On 1/17/2025, "the U.S. Court of Appeals for the District of Columbia Circuit overturned the LNG [Liquefied Natural Gas] by Rail Rule adopted by the U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration [PHMSA] under the [first] Trump Administration. The Rule, adopted in 2020, was challenged legally as recklessly endangering the public by a group of environmental organizations, Tribes, and several state Attorneys General. Delaware Riverkeeper Network and 4 other environmental groups were represented by Earthjustice in the lawsuit. The safety of LNG transport by rail was understudied by PHMSA, according to the court, [the court ruling is available here:

https://drive.google.com/file/d/1tHKAmrl2IG1xNarrhMPxsVs2qSr-XK v/view] and the rule was vacated and remanded, restoring a longstanding ban on the transport of LNG by Rail that was based on public safety. Delaware Riverkeeper Network opposed the transport of LNG for years due to the planned transport of LNG by New Fortress Energy from Bradford County, PA to Gibbstown NJ for export at

the proposed Gibbstown LNG Export Terminal and also worked to stop the transport nationally alongside many communities and organizations across the country."

### **Trump Temporarily Halts Leasing and Permitting for Wind Energy Projects**

Pres. Trump issued an order (available here: https://www.presidency.ucsb.edu/documents/memoran dum-temporary-withdrawal-all-areas-the-outercontinental-shelf-from-offshore-wind) in the form of a "Memorandum for the Secretary of the Treasury; The Attorney General; The Secretary of the Interior; The Secretary of Agriculture; The Secretary of Energy; and The Administrator of the Environmental Protection Agency" entitled "Temporary Withdrawal of All Areas on the Outer Continental Shelf from Offshore Wind Leasing and Review of the Federal Government's Leasing and Permitting Practices for Wind Projects" that directs a full review of wind leasing and permitting practices for both onshore and offshore wind projects and, effective 1/21/2025, pauses all "consideration of any area in the OCS for any new or renewed wind energy leasing" as well as "approvals, rights of way, permits, leases, or loans for onshore or offshore wind projects pending" review. The memorandum does not revoke existing leases, instead directing "the Secretary of the Interior... [to] conduct a comprehensive review of the ecological, economic, and environmental

necessity of terminating or amending any existing wind energy leases, identifying any legal bases for such removal, and submit... recommendations to the President." Also see the article below.


#### Still Unable to Find Equipment Makers, **New Jersey Offshore Wind Project Seeks** 2nd Delay

The Leading Light Wind offshore wind project, which would be built 40 miles off Long Beach Island, NJ and would consist of up to 100 turbines, had previously asked the NJ Board of Public Utilities (BPU), for a pause in the project until late 12/2024, and the BPU had approved the pause. The cause for that request was related to a struggle to find a source for turbine blades. Now, Leading Light Wind has asked the BPU for an additional five months delay, until 5/20/2025, stating that "The offshore wind equipment market continues to experience significant price volatility and the company has not yet identified a solution to that volatility."

### US Supreme Court Rejects Big Oil Attacks on Hawaii Climate Lawsuit

A group of oil companies had filed a petition to the U.S. Supreme Court to hear their case for dismissal of a climate lawsuit brought by Hawaii (i.e., City and County of Honolulu v. Sunoco et al.), and the U.S. Supreme Court has declined to hear the case. This has the result that the case can continue to be heard in the state court, and it has implications for dozens of other state and local lawsuits against oil companies, including several in NJ. The oil industry had argued that the lawsuit sought to regulate interstate and international carbon emissions, which states don't have the right to do, and thus the case couldn't be brought in state court. The Hawaii Supreme Court had previously ruled that the case wasn't about the regulation of carbon emissions, but rather "seeks to challenge the promotion and sale of fossil-fuel products without warning and abetted by a sophisticated disinformation campaign. This case concerns torts committed in Hawaii that caused alleged injuries in Hawaii."

#### OCED Awards Final Two Regional Clean Hydrogen Hubs to Establish Critical Energy Infrastructure in America's Heartland and Mid-Atlantic

From the U.S. Department of Energy (DOE) Office of Clean Energy Demonstrations (OCED) press release: "OCED awarded the Mid-Atlantic Hydrogen Hub, led by Mid-Atlantic Clean Hydrogen Hub, Inc. (MACH2), with \$18.8 million (of the total federal cost share of up to \$750 million) to begin Phase 1 activities. The Hub plans to develop hydrogen production facilities using both established and innovative electrolyzer technologies, which could help reduce costs and drive further technology adoption. The clean hydrogen produced by the Hub would be used in industrial applications - such as power generation and replacement fuel for process heaters - and

heavy-duty transportation, with several refueling stations planned to serve sanitation trash trucks, street sweepers, cargo handling equipment, and fuel cell electric buses." (A community briefing is to be held 2/13/2025 - see p. 5 [note: no longer available on OCED website].)

#### Murphy Seeks to Lock In Key Clean-Energy Goal

Murphy stated: "As you know, our Administration has already set one of the most ambitious clean energy goals in the country: running New Jersey on 100% clean energy by 2035. And taking this step is not merely about reducing our reliance on fossil fuels. This is also about securing our state's energy independence - and creating good-paying, union jobs in the clean-energy industries that will power our future." A bill that would codify the clean energy target (S237) was passed by the Senate Environment and Energy Committee 3/14/2024 but has not moved further, and the Assembly version (A1480) has not yet been voted on by the Assembly Telecommunications and Utilities Committee.

### Bill to Curb Packaging Waste Stalls Again After Critics, Supporters Seek Changes

This New Jersey Monitor article describes the outcome of the 1/13/2025 legislative hearing on the "Packaging Product Stewardship Act" bill (\$3398/A5009). The bill has been considered in the Senate Environment and Energy Committee five times this legislative session, and the latest hearing on it "ended without a vote after calls for changes to the measure by supporters and critics.... Though environmental advocates broadly support the bill, they expressed worry over exemptions that would allow some packaging to continue unchanged if replacements are technologically or financially unfeasible, including packaging that contains toxic materials controlled elsewhere in state law." The bill, sponsored by Sen. ### NJ Coast Protected by Biden's Sweeping Offshore Ban

In November 2024, a letter was sent to then-President Biden from a number of U.S. Representatives, including NJ Representative Pallone, asking him to use his authority under Section 12(a) of the Outer Continental Shelf Lands Act (OCSLA) to permanently withdraw unleased and at-risk areas of the Outer Continental Shelf (OCS) from fossil fuel development. Prior to leaving office, Biden issued a memorandum to "withdraw from disposition by oil or natural gas leasing" the federal waters along the entire Atlantic Coast, most of the Pacific Coast and parts of the Gulf of Mexico. [Note: the link to Biden's memorandum in the article (on the whitehouse.gov website) no longer works, but the memorandum with accompanying map is available in the Federal Register, linked here: https://www.presidency.ucsb.edu/sites/default/files/do cuments with attached files/375719/167797.pdf.] This law has been used by a number of previous presidents, and efforts to overturn any of their previous withdrawals have not been upheld. Overturning the ban would require Congress to pass legislation doing so. A 2018 NJ law bans offshore drilling in NJ state waters.

#### Greenstein, Smith Bill to Prohibit the Trade of Invasive Plant Species Advances from Committee

The "Invasive Species Management Act" (S1029) was reported out of the Senate Environment and Energy Committee. The Act "prohibits sale,

distribution, import, export, and propagation of certain invasive species; [and] establishes NJ invasive Species Council." Under the bill, a "prohibited invasive species" is defined as "an invasive species whose introduction causes, or may cause, substantial economic or environmental harm or harm to human health, or substantially threatens, or may threaten, natural resources or the use of natural resources in the State, which species has been listed in section 4 of this act or the rules and regulations adopted by the department to implement this act." Conditional use waivers for invasive plant species for specific applications under strict and closely controlled conditions would be allowed.

 In one action, New Jersey, California, and Connecticut are filing an amicus brief on behalf of 18 states to support a U.S. Environmental Protection Agency (EPA) Final Rule establishing nationwide drinking water standards for certain per- and polyfluoroalkyl substances (PFAS). In a second case, New Jersey and nine other states have filed a motion to intervene to defend an EPA Final Rule to strengthen the standards for lead in drinking water under the Safe Drinking Water Act [see the article on p. 14].

 In a third case, New Jersey and a coalition of other states and local governments are asking to intervene in lawsuits to defend California's Clean Air Act waiver for several vehicle emissions regulations. These EPA waivers allow California to have cleaner air standards, including for the greenhouse gas emissions from vehicles that contribute to climate change, to go above and beyond federal standards. Among other things, "The 12-page white paper proposes several different ideas such as enacting the Liberty State Park Protection Act, implementing a statewide moratorium on warehouse approval pending a statewide study, and raising state energy efficiency targets...

Increasing New Jersey's energy efficiency goal from the current 2% to a more ambitious 7%... expand[ing] clean energy technology, mandat[ing] electric vehicle charging ports as part of each utility's capital program, restoring funding and staffing to the state Department of Environmental Protection, and ending the bear hunt.... Fulop also mentions a desire to preserve nuclear power... [and that] New Jersey is perfectly positioned to

build the nation's largest network of responsibly developed offshore wind projects and [that] Mayor Fulop has a proven track record of moving towards renewable energy in Jersey City."

#### Support \$3545/A4696 - "Climate Superfund Act"

This bill would hold fossil fuel extractors and refiners that do business in NJ, and are responsible for more than 1 billion tons of greenhouse gas pollution since 1995, liable for damages for the costs of climate change. The bill empowers the NJ State Treasurer to assess the damages caused by climate change over the past 30 years, and the NJ Department of Environmental Protection (DEP) to collect the damages and use the funds for climate mitigation and adaptation efforts. [Note: S3545 was successfully voted out of the Senate Environment and Energy Committee on 12/12/2024.] You can send a letter to Gov. #### • Strengthen and Pass <u>\$237</u>/<u>A1480</u> - "Clean Energy Standard

This bill seeks to achieve 100% clean electricity in NJ by 2035; however, amendments are needed to further support labor and ensure that only truly squeaky clean energy qualifies.

#### Oppose <u>S2425/A3645</u> – "Low Carbon Fuel Standard"

This bill would require New Jerseyans to subsidize expensive dirty alternatives to gasoline (like the misleadingly-named "Renewable" Natural Gas (RNG), biomass-diesel, biogasoline, and fuels produced from carbon capture technology, hydrogen and electrofuels, which worsen climate change and create deadly co-pollutants). The bill's intended theoretical greenhouse gas emission reductions rely on a complex credit trading scheme, creating a market that is prone to fraud, greenwashing, and that may well increase the pollution burden on low income communities of color.

#### Oppose <u>S2827/A4493</u> – "Emissions Reduction Innovation Act"

While its stated intent is to reduce emissions in overburdened communities, this bill ultimately requires ratepayers to give billions of dollars to utilities to subsidize false solutions like the misleadingly-named "Renewable" Natural Gas (RNG), carbon capture, and hydrogen. These approaches perpetuate our reliance on dirty fossil fuels, increase climate and other hazardous air pollution, jeopardize public health and prevent the transition to truly clean renewable energy technologies by extending the operation of polluting facilities.

#### Support <u>53783</u> – Artificial Turf Prohibition for Certain Entities

This bill prohibits municipalities, school districts, and State departments and agencies from purchasing, installing, or using artificial turf.

#### Support <u>SR113</u> – Urges DEP to Cease Funding Synthetic Turf

This bill urges DEP to cease funding synthetic turf field projects through the Green Acres program, and prioritize investing in natural grass playing fields.
